The community and voluntary sector will, once again, maximise safety while at the same time reaching out to the most vulnerable to try and ensure that they are supported through the dark days of winter. Over the past 18 months, we have held several very successful online events to assist community organisations through Covid-19 restrictions, and we will continue to host these in 2022. Last year, we focused on helping community centres, sports clubs, and community childcare centres to survive closure and reopen safely. This year we invited communities to find out about adapting facilities for remote workers as well as encouraging remote workers to take part in community actions. We have all had to adapt and learn how to turn challenges into opportunities in unforeseen times!

One of the most important ways we can help is to support UNICEF Ireland's Christmas Covid-19 Vaccine Appeal and the continuation of their Get a Vaccine, Give a Vaccine: <u>https://www.unicef.ie/donate/get-a-vaccine-give-a-vaccine/</u> - an appeal that Clann Credo staff proudly supported this year. A tiny proportion of people living in low-income countries have received their first dose of Covid-19 vaccine. UNICEF will deliver 3 billion vaccines to the most vulnerable



families, health workers and high-risk people on our planet, however they need your continued support to do this. This Christmas, if you haven't already, we invite you to support the UNICEF mission to 'Give Covid the Jab – because it's not over for anyone, 'til it's over for everyone'.

# **Project Spotlight – Sligo Business Improvement District (BID)**

At Clann Credo we work with all categories of community groups. Many are involved in developing facilities like community centres and sports grounds. Many others are providing essential social services to the community, like meals on wheels, childcare, youth programmes and support for people with disabilities.

We also see positive social impacts delivered by not-for-profit organisations that work to support the economic vibrancy of an area. Many county towns and market towns across Ireland struggle to maintain the level of footfall required to keep businesses viable. So, we were delighted when Sligo Business Improvement District, or BID, came to us with great ideas for events, festivals, seasonal decorations, and activities that would animate and boost businesses in the town.

The Sligo BID is an initiative designed to increase business in the town, to attract more businesses and to secure a long-term sustainable model for the management of the town. Sligo BID represents 758 businesses in the urban area and membership is designed to benefit all businesses.

The organisation was established in accordance with Section 129C of <u>the Local Government (Business</u> <u>Improvement Districts) Act 2006</u> and was voted in by more than 80% of local businesses.

Since its establishment, Sligo BID has undertaken many varied projects including:

- The provision of new coach parking spaces in Sligo
- Managing St Patrick's Day Parade
- Management of the scheme of Christmas lights for the city
- Further development of tourism promotion of County Sligo including attendance at trade fairs and production of marketing and promotional material
- Working to develop the 'Meet in Sligo' project to promote, market and sell Sligo as a destination for meetings, conferences and events.

Sligo BID maintains a core focus of working with local businesses, tourism bodies and the County Council. Gail McGibbon, CEO, stated that the support and assistance from Clann Credo has a positive impact on local projects "Working with Clann Credo helps us move at a faster pace in completing projects and perhaps allows us to aim a little higher in ambition".

In these uncertain times, their traditional Christmas light project bring important familiarity, hope and comfort to all.



# Community Action Against Climate Change – How Can Clann Credo Help?

## Reminder! Upcoming Sports Capital & Equipment Programme

Every year, Clann Credo works with many community groups and local sports clubs that are making applications to the Sports Capital and Equipment Programme. It is an extremely important source of funding for community owned sports and activity facilities.

This year, Clann Credo supported over 130 applicants by providing loan approvals that showed they had their match funding requirement. It is essential that each application clearly demonstrates there is enough finance to complete the proposed project.

While we don't know exactly when the Sports Capital & Equipment Programme will announce the final grants from this year's round of applications, or re-open for new applications, we do know that it is never too early to get in touch with us if your group or club is thinking about investing in sports facilities. Our Social Finance Executives have lots of experience working with clubs and groups who have big plans, but not quite enough finance!
